

PRIVACY POLICY

At Accelskill Academy, we are committed to protecting your privacy and ensuring the security of your personal information. This Privacy Policy outlines the types of information we collect, how we use and protect it, and the choices you have regarding your data.

1. Information We Collect:

- We may collect the following types of personal information from students, staff, visitors, and other individuals associated with Accelskill Academy:
